# Code of Conduct

RTD's Code of Conduct establishes reasonable expectations in accordance with the California Penal Code (PC) and Stockton Municipal Code (SMC) with regards to behavior for all persons on RTD property. Any person who fails to comply with the Code of Conduct may be removed from the property or be prohibited from RTD's facilities, vehicles, and services. In addition, failure to comply may result in the following: citation, removal, expulsion, arrest, criminal prosecution, and/or further penalty.

RTD enforces this Code of Conduct to ensure a safe, reliable, efficient, and pleasant experience for its passengers. Please help us make this a comfortable and inviting atmosphere by following our Code of Conduct.

## While on RTD property, you are prohibited from the following:

### Causing Harm

1. Carrying unauthorized weapons, explosives, acids, flammable liquids, or dangerous materials that are likely to cause harm.
2. Engaging in any act of violence, harassment, or intimidation. This includes fighting, using physical force, or threatening any person (including employees). RTD will NOT tolerate any form of abuse.
3. Smoking or vaping (e-cigarette).
4. Giving off unbearable and obnoxious odors (e.g., unlaundered clothing) that may be a public health concern.

### Misuse of Property

5. Destroying, damaging, tampering, or defacing RTD property or the property of its customers and tenants.
6. Obstructing facility and vehicle entrances or interfering with the free flow of pedestrian traffic.
7. Littering, spitting, defecating, and urinating on property.
8. Riding a bike or scooter, running, rollerblading, or skateboarding on RTD property.

### Inappropriate Behavior

9. Loitering, delaying, or lingering about the property or its exterior.
10. Soliciting, picketing, handbilling, distributing, selling materials, or gambling on RTD property.
11. Using radio and cell phones that cause noise.
12. Possessing an open alcoholic beverage or being intoxicated.
13. Possessing, selling, or using unlawful drugs or related paraphernalia.
14. Using or wearing apparel that has offensive language or gestures, including racial, religious, sexual, or ethnic slurs.
15. Wearing clothes that do not appropriately cover one's body and undergarments.
16. Wearing any clothing or other items that seek to conceal your identity. (Facial masks not included due to pandemic.)
17. Jaywalking, roughhousing, or other unsafe behaviors.
18. Evading fare payment or misusing fare. This includes failure to show I.D. for reduced fare when requested and/or using outdated passes. While on the BRT, please have proof of payment ready.
19. Eating and/or drinking on the bus. Food and drink must be fully sealed and put away for the duration of the trip.
20. Moving about while bus is in motion.
21. Bringing animals that are not in a pet carrier, except for identified service animals.
22. Storing personal items or cargo on the seat next to you. Personal items should not exceed storage
