

## **San Joaquin RTD – Access for All Program**

### **Call for Projects (CFP)**

Fiscal Year 2025–2026

#### **Program Overview**

San Joaquin Regional Transit District (RTD), in its role as the Local Access Fund Administrator (LAFA) for San Joaquin County, invites eligible organizations to apply for funding under the California Public Utilities Commission's (CPUC) Access for All Program. The purpose of this grant is to support the expansion or enhancement of on-demand wheelchair-accessible vehicle (WAV) transportation services.

Total available funding for this cycle is \$149,754. A minimum of 85% of these funds will be awarded to Access Providers. RTD may retain up to 15% for administrative use.

#### **Eligibility**

Eligible applicants must:

- Provide or contract to provide on-demand WAV service within San Joaquin County.
- Be a public agency, nonprofit organization, or private entity.
- Demonstrate compliance with CPUC requirements for Access Providers, including:
  - Background checks
  - Insurance
  - Drug & alcohol program
  - California Highway Patrol Motor Carrier Profile and CA Number
  - Secretary of State registration

#### **Project Requirements**

Projects must:

- Expand or enhance WAV service availability, reliability, or reach.
- Be on-demand in nature (not fixed-route or prescheduled paratransit only).
- Launch within a reasonable time frame.
- Include outreach strategies and accommodations for riders without digital access.

#### **Timeline**

Call for Projects Opens: July 15, 2025

Deadline to Submit Questions: September 19, 2025

Application Deadline: October 3, 2025, by 5:00 PM PT

Application Review Period: October 13-24, 2025

Award Notification: Early November 2025

Contracting Begins: Early 2026

### **Evaluation Criteria**

Applications will be evaluated by a panel including members of RTD and Access San Joaquin. The criteria and point values are as follows:

- Project Readiness & Experience (10 pts)
- Outreach & Inclusion (25 pts)
- Safety & Compliance (10 pts)
- Operational Plan (20 pts)
- Budget & Cost Efficiency (15 pts)
- Innovation & Sustainability (10 pts)
- Monitoring & Evaluation Plan (10 pts)

Total: 100 points
